

# ICAI Four Weeks Residential Programme for Men Participants on Professional Skills Development at the Centre of Excellence(COE), Hyderabad (30th March, 2015 to 25th April, 2015)

## Course Objective

The programme aims to help the Chartered Accountancy students and newly qualified Chartered Accountants in imbibing the professional skills required for effective functioning in business organisations and the profession. The Programme environment focuses on development of communication skills, personal qualities, interpersonal and teamwork skills, problem solving skills and leadership skills.

## Eligibility

Only Men students who have passed Chartered Accountancy IPCC/ PCC/ PE – II Examination and pursuing last year of article training or completed Articleship training are invited to join the course. Recently qualified Women Chartered Accountants, say 2-3 years, are also welcome to join the course.

## Part of Practical Training

Under Explanation (1) to Regulation 59 (7) of the Chartered Accountants Regulations, 1988, participation in the Residential Programme on Professional Skills Development will be considered equivalent to undergoing articulated training. Thus the period during which the training is undergone will be considered as an integral part of practical training.

## Course Content

The programme would be divided in various modules covering:

- Developing Personal Traits
- Business Communication & Presentation
- Interpersonal & Negotiation Skills
- Business - Social Etiquettes
- Practice Development and Management
- General Management
- Current Affairs

## Course Methodology

Modern education techniques would be used to make learning wholesome and

interesting. The course methodology will involve:

- Class/Group Discussion
- Management Games
- Role Plays
- Simulation Exercises
- Case Studies

The programme is residential.

## Course Duration

The schedule dates for next batch is from 30th March, 2015 to 25th April, 2015.

## Selection Criteria

In case of over-response, students will be selected on the basis of logical criteria. First preference may be given to the qualified Chartered Accountants. Candidates who had applied but were refused admission in the earlier batches will also be appropriately considered. Selection of the candidates who will be allowed to undergo the programme will be made by Board of Studies or by a person/group of Board of Studies. All decisions by the competent authority on selection will be final and binding. Intimation will be sent on selection/ non-selection. No other correspondence on selection or non-selection shall be made.

## Course Fee

Rs. 40,000/- per participant for Four Weeks Residential Programme. The course fee includes tuition fee, course material, boarding, lodging, local field visits (one), etc. Applicants may register by paying 20% of the fees and the balance is to be paid before starting of the course. The payment should be made online using Credit card or Net Banking facility.

## Exemption from Payment of Fees to top 10 rank holders

As per the decision of the Council, top 10 rank holders of the Professional Competence Examination (PCE)/ Integrated Professional Competence Examination (IPCE) and Final Examination effective from November, 2010 examination onwards are exempted from payment of fees for attending the residential programme on Professional Skills Development Programme.

## Exemption from GMCS

### • 15 days GMCS Course

The students who have registered for article ship training before 1st May, 2012 would not be required to undergo 15 days GMCS course separately. A student who has already paid fees for the GMCS course and has not undergone the actual course may claim the refund of fees on account of GMCS course directly from the region/branch where such fees had been paid subsequent to the selection in a batch of Professional Skills Development Programme.

### • GMCS II under new Scheme

The students who have registered for article ship training on or after 1st May, 2012 would not be required to undergo GMCS II course separately.
