Transparency – The Means of Success for Leaders

In current scenario of working life, employees have become tired of surprises and want to exist in a work environment that allows one to have a greater clarity of thought – by eliminating the surprises that continue to creep into their minds with each decision they make. As employees seek to be aware of what is real and true, trust and transparency have become popular in workplace. Employees just want transparency so that they can plan and protect their future. They desire their leaders to be proactive in sharing where the organization is headed and forthright about its future.

The reason most leaders are not transparent is because they believe they will be viewed as less authoritative; that the credentials they worked so hard to attain will lose their power & leverage. This is the problem with most leaders, they are not aware of the reality that exists around them. People want to relate to its leaders. People want to know that their leaders have experienced the same problems and how they have overcome their hardships.

The digital age has allowed people to learn more about their leaders. As such, social media has suddenly given people the permission to enter a leader's personal space; a place they were previously prohibited from entering. The digital age has changed the levels of transparency that we expect from people too.

Five powerful things that happen when a leader is transparent:

- 1. Teams Are Built Easier: Team building through transparency can take a better shape when the leader of a team can openly discuss what he believes about the strengths and weaknesses of the team. It allows everyone to openly share their opinions which allow the group to mature together and find creative ways to discover the best mix or match to deliver as per the client's expectations.
- 2. People Begin to Promote Trust in Their Leader: If a leader is transparent, it strengthens the leadership as people begin to trust and they will respect as a leader. Employees may have trusted their leaders in the past, but after their leader becomes transparent their employees are now more willing to promote trust in their leader with others.
- 3. Higher-Levels of Performance Emerge: The lack of transparency when exists among leaders in the workplace it leads to less optimal levels of performance. The success and significance of being a great leader who served to inspire hope and opportunity is not by allowing power but by standing in the way of honesty, authenticity and being genuine with people.
- Relationships Grow Authentically: It brings people come together as a group. Also it is to be noted that transparency allows relationships to mature faster, as openness can potentially avoid misunderstandings that can bring unnecessary tension.
- 5. Problems Are Solved Faster: When the leaders are transparent, employees learn more about one another and can grow to work toward solving the problems faster. For example, a boss challenges his staff to reduce the budget every quarter. The boss told the situation to one of his colleague that "I am being told that I must achieve a specific bottom line performance this year and if I don't, I am going to have to cut staff. I would rather not scare anyone." The colleague responded by recommending that if he openly shares his concerns with his team and that if someone was not able to handle the truth - then he would discover another problem. In other words, the boss' senior team would be more effective at designing a strategy to exceed performance requirements - rather than cutting a budget. They did and the boss learned a valuable lesson about how to solve problems by being transparent about them.

In the words of Philip Zimbardo, a good cult delivers on its promises. A good cult nourishes the needs of its members, has transparency and integrity, and creates provisions for challenging its leadership openly. A good cult expands the freedoms and well-being of its members rather than limits them.
